This table provides feedback on the syllabus and its delivery as perceived by students, using a five-point scale ranging from "Strongly Agree" to "Strongly Disagree." Here's an analysis of the results:

Key Observations:

1. Content Continuity:

- Majority (68.15%) of students either strongly agree or agree that the continuity of course content is appropriate, suggesting a largely positive perception.
- Only a small fraction (20.4%) disagree or strongly disagree.

A consistent flow in core topics like programming, database management, and emerging technologies (e.g., AI, ML) is vital for a strong technical foundation.

2. Depth of Content:

- A significant 69.31% of students find the depth of curriculum content appropriate.
- However, a noticeable minority (19.55%) express dissatisfaction.

The depth must enable students to analyze and solve complex business problems, balancing theoretical frameworks with real-world applications. In-depth knowledge is essential to handle advanced coding, system analysis, and software development tasks.

3. Industry Orientation:

0

o 68.3% of students believe the syllabus is industry-oriented, which is critical for career alignment.

Industry-relevant syllabus aids in bridging theoretical concepts with practical business scenarios, crucial for roles like managers and analysts. Aligning coursework with current IT trends ensures students are ready for roles like software developers, system architects, or data scientists.

4. Clear Objectives and Outcomes:

o A lower percentage (62.05%) agree that objectives and outcomes are clearly stated, indicating room for improvement in transparency.

Clear course objectives guide students in achieving strategic thinking, decision-making, and leadership skills. Well-defined outcomes ensure students are proficient in both foundational and cutting-edge technologies, preparing them for dynamic tech roles.

5. Balance Between Theory and Practical:

A strong 68.01% find the balance appropriate, though 20.45% show disagreement, suggesting the need to re-evaluate certain aspects of the curriculum.

6. Relevance of Electives:

 The highest agreement (71.44%) is noted for the relevance of electives to the latest technology, reflecting alignment with current trends.

7. Employability Skills:

 Approximately 67.73% feel the curriculum enhances employability skills, a critical indicator of its effectiveness.

8. Industry-Academic Gap:

 With 69.2% agreeing that the curriculum bridges the industry-academic gap, the institution seems to address this challenge well.

Partnerships with industry for live projects, internships, and guest lectures help reduce the gap and improve practical exposure. Incorporating tools, languages, and platforms used in the IT industry ensures a smoother transition from academics to professional roles.

9. Holistic Development:

 About 67.11% agree that the curriculum supports professional ethics, teamwork, and leadership, showing a focus on overall student development.

Promotes leadership, ethics, and a global perspective, which are vital for managing diverse teams and projects. Cultivates teamwork, ethical coding practices, and awareness of environmental and societal impacts of technology.

This feedback evaluates the effectiveness of the syllabus and its delivery from the perspective of teachers, a crucial stakeholder group. Below is an analysis of each parameter with relevance to MBA (Master of Business Administration) and MCA (Master of Computer Applications) programs:

1. Learning Objectives

- Observation: 74.62% of teachers strongly agree or agree that learning objectives are clear and
- Relevance to MBA: Clearly defined objectives help MBA students grasp business concepts like strategy, operations, and finance with clarity and relevance to industry needs.
- Relevance to MCA: Learning objectives guide MCA students to focus on technical competencies like coding, software development, and systems analysis, ensuring alignment with technology trends.

2. Syllabus Organization

- Observation: 68.33% agree the syllabus is well organized and suitable. However, 18.82% show dissatisfaction.
- MBA: A well-organized syllabus ensures smooth progression across subjects like economics, marketing, and HR, emphasizing integration of case studies and practical learning.
- MCA: Structured syllabus helps in building a logical sequence of learning, starting from programming fundamentals to advanced topics like AI and cloud computing.

3. Reference Material

- Observation: 73.78% agree textbooks and reference books are suitable, with 17.27% dissent.
- MBA: Up-to-date reference materials, including case study repositories and global business texts, enhance learning outcomes.
- MCA: Standard textbooks and online resources for coding, data structures, and algorithms are critical for in-depth technical learning.

4. Curriculum Design System

- Observation: 76.64% of teachers view the university's curriculum design process as effective.
- MBA: Regular review mechanisms ensure the inclusion of emerging areas like fintech, sustainability, and global business trends.
- MCA: Curriculum revisions incorporate rapid technological changes, equipping students with cutting-edge skills.

5. Curriculum Updates

- Observation: 74.21% believe the provision to update the curriculum is adequate.
- MBA: Frequent updates ensure topics like digital transformation, data analytics, and agile management remain current.

- Observation: 71.94% agree that contact hours are appropriately distributed, though 20.14% show concern.
- MBA: Balance between lectures, case discussions, and project work must be reviewed for areas requiring more interactive learning.
- MCA: Contact hours should allocate adequate time for coding labs and project-based learning.

7. Balance Between Theory and Practical

- Observation: Similar to contact hours, 71.94% agree on the balance between theory and practical.
- MBA: Incorporation of practical activities like business simulations and internships complements theoretical knowledge.
- MCA: Practical sessions, especially in labs, are crucial for mastering coding and software applications.

8. Electives and Technological Advancements

- Observation: 74.21% feel electives align with technological advancements.
- MBA: Electives in AI-driven decision-making, blockchain in business, and marketing analytics are vital for keeping the program relevant.
- MCA: Electives on cutting-edge technologies like IoT, machine learning, and DevOps provide students with future-ready skills.

9. Organization and Clarity of Curriculum

- Observation: 76.64% agree the curriculum is well-organized and easy to follow.
- MBA: Clarity ensures students can integrate concepts across finance, marketing, and operations.
- MCA: Easy-to-follow curriculum aids students in progressing from basic to advanced technical topics efficiently.

10. Socio-Economic Relevance

- Observation: 73.78% agree the curriculum addresses socio-economic needs.
- MBA: Focus on sustainability, global business, and social entrepreneurship ensures graduates contribute to society.
- MCA: Emphasis on technologies like green computing and socially responsible AI aligns with societal needs.

11. Academic Flexibility

- Observation: 68.33% agree the curriculum has good academic flexibility, while 18.82% express concern.
- MBA: Flexibility in electives and interdisciplinary subjects allows students to customize their learning paths.

Observations:

- 1. Industry Needs (Parameters 1 & 7):
 - The agreement that the curriculum caters to industry needs is moderate, with "Agree" and "Strongly Agree" collectively accounting for over 61% of responses.
 - There is room for improvement, as nearly 25% of employers were neutral or disagreed.
- 2. Employability Skills (Parameter 2):
 - The strongest positive response, with over 71.5% agreement. This indicates employers believe the curriculum significantly enhances employability skills.
- 3. Theory and Practical Balance (Parameter 3):
 - Employers largely feel the curriculum balances theory and practice, with 69.23% in agreement. A small portion of respondents, however, disagreed or felt neutral.
- 4. Industry-Academia Gap (Parameter 4):
 - o While the majority (65.93%) feel the curriculum bridges the industry-academic gap, 26.45% remain unconvinced. This highlights a potential area for stronger integration.
- 5. Professional Development (Parameter 5):
 - o A solid 69.51% agree that the curriculum supports the development of professional ethics and related skills. However, about 18% either disagreed or were neutral, suggesting some content
- 6. Innovativeness and Creativity (Parameter 6):
 - This parameter received strong support (74.71%), showing the curriculum is perceived to foster innovation and creativity effectively.

Conclusion:

Overall, the curriculum is well-received, particularly in employability and creativity development. However, there is scope for improvement in aligning with industry needs and bridging the academic-industry gap.

1. Prerequisite Knowledge for Employability

Positive Responses (Strongly Agree + Agree): 66,34%

Alumni largely agree that the curriculum provides the foundational knowledge necessary for employability. However, 24.14% (Neutral to Strongly Disagree) indicates there is room to enhance the rigor of basic and prerequisite knowledge, particularly for the MCA program, where technical skills play a critical role.

Improvement Opportunity: Include more foundational and preparatory modules, especially for students transitioning from non-technical or non-business backgrounds,

2. Learning Experience and Employment Utility

Positive Responses: 70.98%

The curriculum is perceived as useful for employment by a significant majority of alumni, This is especially relevant for MBA graduates, given the focus on managerial and operational learning, MCA alumni, however, might benefit from more hands-on industry exposure.

Improvement Opportunity: Introduce internships and industry projects to further solidify the practical relevance for MCA students.

3. Technological Advancements and Electives

Positive Responses: 70.37%

Alumni feel the electives are aligned with technological advancements, which is critical for MCA courses dealing with rapidly evolving tech. MBA electives related to digital transformation, analytics, and strategy also seem relevant.

Improvement Opportunity: Conduct periodic reviews to ensure electives remain cutting-edge, especially in fields like AI, machine learning, and fintech for MCA and MBA.

4. Relevance of New Courses

Positive Responses: 69.63%

Alumni acknowledge that new courses align with current industry demands, which reflects a proactive curriculum update approach by the institution.

soft skills like leadership and team building are key, and MCA, where professional growth is often
tied to technical expertise.

Improvement Opportunity: Enhance mentorship programs and extracurricular activities focusing on leadership, ethical values, and collaboration for MBA and MCA.

7. Effectiveness in Meeting Professional Standards

Positive Responses: 72.94%

Alumni agree that the curriculum effectively supports their current professional roles. MBA alumni
might value the managerial and strategic focus, while MCA alumni appreciate the technical
grounding.

Improvement Opportunity: Strengthen this by offering certifications aligned with industry standards like PMP, Six Sigma for MBA, and AWS, Cisco certifications for MCA.

8. Application of Knowledge in Real-Life Situations

• Positive Responses: 72.25%

Alumni find the curriculum effective in real-world applications, which is encouraging. This balance
of theoretical knowledge and practical implementation benefits both MBA and MCA graduates.

Improvement Opportunity: Incorporate case studies, hackathons, and business simulations to enhance practical learning further.
