### Action Taken Report AY (2021-2022)

#### | Action Taken: (Students)

As we are an affiliating institute and affiliated to Savitri Bai Phule Pune University, we have certain limitations in adding our views in our syllabus determination process. The syllabus of every course is prepared by respective BoS, as nominated by the University, though we have taken the following steps to enhance the syllabus:

- 1. The institution keeps organizing seminars, workshops, conferences and guest lectures regularly. Eminent personalities from academia and industry are invited to address the students and share with them practical insights to the corporate world and business environment. They provide a practical side to the theoretical concepts learnt by students in various disciplines to consolidate their learning. They also provide inputs to strengthen the curriculum further. Their feedback is taken during interaction with the Director and faculty during correspondence for the event and on the day of the event. Students and faculty stay connected with the resource persons for future updates.
- 2. To enhance the employability skills of the students, Content Beyond the syllabus are prepared and delivered by faculty members. Self-paced courses in COURSERA and NPTEL-SWAYAM courses are encouraged by faculty members for students to enhance their skills.
- 3. The syllabus should be changed every three years and be in line with changing needs of the business.
- 4. However we see that Curriculum structure and contents help to enhance employability skills and Curriculum bridges the gap between industry and academic are the two areas where major focus has to be given.
- 5. The feedback is regularly discussed at various committees and invites suggestions to improve it further.

#### Action Taken: (Teachers)

The Institute is affiliated to Savitribai Phule Pune University and hence has to follow the syllabus as decide by the University, but any changes or improvements and challenges can be placed before the University. For teachers, the feedback addressed issues like suitability the course and its need base, outcomes of the curriculum, relationship with course content and corresponding reference material, availability of reference materials in terms with curriculum, evaluation methods and curriculum delivery, etc.

We have taken following actions-

1. Being affiliated to Savitribai Phule Pune University, the Institute cannot take any action in matters to design and development of curriculum so the gaps in curriculum are identified and communicated to Savitri Bai Phule Pune University.

2. Faculty members are suggested to attend and present the conference to improve their research interest.

### Action Taken: (Employers)

For employers, it addressed issues like general communication skills, developing solutions to real life problems, working in a team, creative challenges to challenges, organization skills, learning of new techniques, integration of technology for work as learnt through the curriculum.

1. Students should undergo Internship programs and an Internship Committee is to be set up at the Institute level to strengthen the Internship Program for the students. The IQAC Cell monitors the entire process of Students Internship.

2. The Employers stressed upon revision of syllabus and to reduce the gap between theory and practise.

- 3. Career Guidance cell should be established and various programs from time to time should be inculcated among the students
- 4. Recruiters suggested that the students are to be strong in their aptitude skills so intensive training on aptitude is planned from next academic year.

#### Action Taken -(Alumni)

1. As per the feedback the following points are noted and action is taken on them-

- 2. More emphasis should be on the Inter-disciplinary Specializations. Students were encouraged to take major and minor subject choices for enhancing their skill set.
- 3. Suggestion to include the basics of stock market, mutual funds, bitcoins and other investment policies cultural management courses. Core courses should not be made as choice based or elective courses.
- 4. Curriculum needs to be updated, with highest emphasis on the basics, instead of simply problem solving and memorizing.
- 5. Application based syllabus challenging the students aptitude needs to be introduced.
- 6. Courses need to be updated with respect to market standards. Additionally, there should be better industry tie up with the institution.
