Action Taken Report AY (2020-2021)

- The syllabus has been revised to provide adequate knowledge for the students after careful consideration of the feedback from all the stakeholders.
- 2. Apart from subject knowledge measures have been taken to provide additional inputs and Ideas of the concepts which are relevant to the current job market requirement with special focus on hands-on industry relevant practical experience and internship work/ project work.
- 3. Extensive exposure and practical knowledge to be imparted to the future by the institute learning material, lesson plans, course notes, etc.

Action Taken: (Students)

As we are an affiliating institute and affiliated to Savitri Bai Phule Pune University, we have certain limitations in adding our views in our syllabus determination process. The syllabus of every course is prepared by respective BoS, as nominated by the University, though we have taken the following steps to enhance the syllabus:

- Industry Expert sessions are conducted to help understand the expectations of the industry from students and more clarifications are made on certain theoretical terms by the Industry experts.
- 2. To enrich the library facility, we constantly order text books and reference books, and also improve its infrastructure and administrative reach.

- 4. Various additional lectures and trainings are conducted to improve the students learning ability.
- 5. After the end of the course, Faculties share notes, ppts, and question banks for better preparation with the students.
